Spezifisches Bildungsziel und erwartete Lernergebnisse (zusätzliche Informationen)	<p>The course refers to the typical educational activities and belongs to the scientific area of Law.</p> <p>Specific objective of the course is the acquisition of basic knowledge and competences in financial law with particular reference to the intermediation in the banking market and in the financial market.</p> <p>The professional competences of the course are integrated with the curriculum of the degree course in Economics, Politics and Ethics as well as Economics and Management and are devoted to the qualification of the firm and of the companies from a legal perspectives for the aim of the understanding of the relative institutes with the scope of understanding of the legal institutes functional to the acquisition of the professional competences typical of the professional jobs of the degree programs.</p>
