<p>Art der Prüfung</p>	<p>For both Attending Students and Non-attending students:</p> <p>Individual written essay (weight 80%) In this essay, the student should report a literature review on a relevant research question within the field of Tourism Management. The choice of topic is free,</p>

	<p>however, its relevance needs to appear in the study. The study should be based on a minimum of 15 relevant and high-quality (academic) sources, that provide relevant insights into the concepts mentioned in the research question.</p> <p>The student should add an overall reflection on the practical implications of the findings in the literature. This can be a reflection based upon personal experiences. No empirical work is required.</p> <p>The study should be reported in an academically styled written essay (3000 – 6000 words) and should be submitted for examination no later than one week before the scheduled exam date. (ILO1, ILO2, ILO3, ILO4)</p> <p>Final written exam (weight 20%): n. 10 multiple choice questions and n. 1 open question on academic and thesis writing (ILO1, ILO2, ILO5)</p>
Bewertungskriterien	<p>The assessment of the essay (literature study) is based on five main criteria. Overall readability (20%) refers to the structure, consistency, quality of English, professional presentation, and accessibility of the text. The introduction (15%) concerns the relevance of the topic, the clarity in developing the problem area, and the focus of the research question. The literature section (30%) considers the quality of the search and selection process, the coverage of key concepts, the reflection and critical review, and the coherence of the narrative. Reflection and discussion (25%) are evaluated in terms of authenticity, critical insight, and depth of analysis. The conclusion (10%) focuses on the clarity with which the research question is addressed, the acknowledgement of limitations, and the practicality of the recommendations.</p>
