<b>Inhaltsangabe</b>	<p>The course Research Change LAB deals with:</p> <ul style="list-style-type: none"> <li>• The meaning of conducting a research project and developing a thesis</li> <li>• Conducting a literature review</li> <li>• Choosing among alternative research methodologies (quantitative and qualitative)</li> </ul> <p>The course provides students with theoretical knowledge and</p>

	practical tools on how to develop their thesis. Students are required to work on the design of a small research project, which may serve as the foundation for their thesis project.
<b>Themen der Lehrveranstaltung</b>	<p>The course is divided into 3 modules:</p> <p>A. Conducting research and writing a thesis;</p> <p>B. Writing a literature review;</p> <p>C. Choosing among alternative research methodologies.</p> <p>In Module C, quantitative (survey data collection, use of databases, and data analysis) and qualitative research methods are presented.</p>

The development of communication competences assumes heterogeneous situations such as, for example, the presence of internal stakeholders (e.g. colleagues, managers, owners), or external stakeholders (e.g. potential investors, suppliers and other business partners) and the ability to sustain an adversarial process;</p>

<b>Art der Prüfung</b>	<p>100% Project work</p> <p>The project work consists of the design of a (small) research project on a topic of interest for the student. The student has to design the research project individually according to the concepts and best practices presented during the course. The student has time to work on the project during the course (in-class activity). On the day of the exam, the student has to deliver a written report on the project work.</p> <p>(ILOs: 3, 4, 5).</p> <p>Students attending less than 75% of the lectures will automatically fail the course.</p>
<b>Bewertungskriterien</b>	<p>It is relevant that the student demonstrates to be able to correctly apply the concepts and best practices presented during the course, especially with respect to structuring the research project, defining the boundaries of a literature review, and identifying the most appropriate quantitative or qualitative research method.</p>
