	<p>outcome emphasises an interdisciplinary approach to problem-solving and organisational analysis.</p> <p><b>ILO 1.2</b></p> <p>Within the Data Analytics for Economics track, students will acquire advanced knowledge in economic theory, economic analysis, and econometrics through the study of microeconomics and macroeconomics, decision theory under uncertainty, time-series analysis and forecasting techniques, and methods for causal inference using both administrative and experimental data.</p> <p>Additionally, students will develop competencies in data analysis, applying quantitative and computational approaches to address complex economic problems.</p>
	<p><b>ILO 2 Applying knowledge and understanding:</b></p> <p><b>ILO 2.1</b></p> <p>Students will demonstrate the ability to analyse business-related issues that underpin data-driven decision support by applying statistical models and computational modelling techniques. This outcome focuses on integrating quantitative methods to evaluate and optimise organisational decision-making processes.</p> <p><b>ILO 2.2</b></p> <p>Students will demonstrate the ability to utilise and apply models designed for market analysis and for the formulation of economic policies. This outcome emphasises the integration of theoretical and empirical approaches to support evidence-based policy development and strategic decision-making.</p>

<b>Art der Prüfung</b>	<p>Written and project work: written exam with review questions and project report done in groups.</p> <p><b>For Attending Students:</b></p> <ul style="list-style-type: none"> <li>• Team Project Report and Presentation (30%): Students will collaborate on a comprehensive project report that is relevant to the course's subject matter. This report will be accompanied by a presentation, where each team will articulate their findings and recommendations (ILOs 1-5).</li> <li>• Written Exam (70%): The exam will consist of review questions designed to test students' understanding of the course material.
