Ressumè di contegnus	The course is designed to introduce students to the fundamental concepts of corporate governance from various angles – the board of directors, senior management, regulators and other stakeholders – and their governance roles and responsibilities. The main subject areas covered are: a) the principles of corporate governance; b) the roles and tasks of shareholders, management, and the board of directors; c) proxy voting, activist investors, say on pay; d) the regulatory framework; e) corporate ethics and conduct; f) international corporate governance.

Argomenc dl curs	The main subject areas covered in the course are: -the principles and players of CG; -the board of directors and its specialized tasks; -the regulatory framework; -shareholder's activism; -regulatory frameworks, -codes and legislation, -corporate ethics and culture, -international corporate governance. Please note this list of topics is tentative and we may adapt it as the course progresses.

Prerequisic aconsiés	No prior experience or prerequisite academic background is necessary to do well in the course. Undergraduate introductory courses in finance will be beneficial.

Modalité de enseignament	This course will use a combination of lectures, scientific articles, case discussions, professional expert presentations and online reading to study corporate governance. Class activities will be a mix of lecture, case study presentations, and interactive class discussions aimed at demonstrating a principle in action. Class participation and active discussion is both expected and encouraged to apply theoretical concepts to realistic business-related situations. Students are expected to have thoroughly read all the assigned material in advance of the class to ensure a meaningful class participation. The course will also host Guest Lecturers that will present specific corporate governance issues and practices.

Obietifs formatifs y competenzes da arjonje	Knowledge and understanding: Understanding of the field of corporate governance, its core

(informazioni supplementares)	concepts and terminology, its relevance and practices, as well as some debates in the field. Students will understand the key mechanisms of corporate governance, the policies influencing them, and the empirical methods used in this subject. Applying knowledge and making judgement: The course will focus on assessing the effectiveness of governance roles and responsibilities, understanding strengths and weaknesses, recognizing the implications of behaviors and actions. Students will develop skills for addressing difficult governance situations and discuss the topics that continue to spark scientific and regulatory debates. Governance is contextual and requires judgment. Students should expect to grapple with ambiguous situations that do not have simple solutions. Communication and Learning skills: Ability to present in oral and written form an analysis of business solutions in response to specific issues related to corporate governance and business ethics.
Sort de ejam	For attending students, the final grade will be a mixture of participation in case study discussions/presentations/written works and mid-term assignments and exam(s) (ILOs 1-5). For non-attending students: written final exam (100%) (ILO 1-5). Detailed point breakdown for individual assignments etc will be provided in the first lecture as it depends on the availability of guest speakers and case studies.
