Inhaltsangabe	Der Kurs bietet eine fortgeschrittene Perspektive auf das betriebliche Rechnungswesen und konzentriert sich darauf, wie finanzielle und nicht-finanzielle Informationen die Entscheidungsfindung, die Kontrolle und das Leistungsmanagement unterstützen. Der Kurs befasst sich mit Kalkulationstechniken, Budgetierung und Abweichungsanalyse, Verrechnungspreisen und Leistungsmessung in verschiedenen

	<p>organisatorischen Kontexten. Analytische Instrumente wie prädiktive Modellierung, Simulationen und ERP/BI-Anwendungen werden als Ergänzung zu den Konzepten des Rechnungswesens vorgestellt, so dass die Studierenden in der Lage sind, komplexe Managementaufgaben mit größerer Einsicht anzugehen.</p>
Themen der Lehrveranstaltung	<p>This course integrates advanced managerial accounting topics with foundational elements of business analytics and performance measurement. It focuses on preparing, evaluating, and interpreting financial and non-financial information to support managerial decision-making and control across different types of organizations (e.g., manufacturing, service, for-profit, and non-profit). Topics covered include advanced cost allocation techniques (such as Time-Driven Activity-Based Costing), variance analysis, fundamentals of predictive analytics, Monte Carlo simulations and uncertainty, interactive data visualizations for managerial decision-making, and the recording of basic transactions in an Enterprise Resource Planning (ERP) system.</p>
