Inhaltsangabe	Dieser Kurs führt die Studierenden in die Formulierung und Umsetzung von Strategien ein, wobei der Schwerpunkt auf der Wertschöpfung jenseits kurzfristiger Gewinne liegt. Er behandelt zeitgenössische Theorien, Rahmenwerke und Instrumente zur Analyse des Wettbewerbsumfelds, einschließlich technologischer und geopolitischer Trends, sowie interner Ressourcen und Fähigkeiten. Zu den Themen gehören Wettbewerbsvorteile,

	<p>Unternehmensstrategie und Veränderungsmanagement, unterstützt durch Vorlesungen, Gastredner, Falldiskussionen und Gruppenarbeit. Die Studierenden vertiefen ihr Verständnis für strategische Entscheidungen, die Einbeziehung von Stakeholdern und die Rolle von Einzel- und Teamentscheidungen.</p> <p>Die Bewertung bietet zwei Optionen: A. interaktive Option, die mehr als 80 % Anwesenheit, Teilnahme, Einzel- und Gruppenaufgaben sowie eine kurze schriftliche Prüfung erfordert; B. Selbststudium ohne Anwesenheit und mit einer umfassenden Abschlussprüfung.</p>
<p>Themen der Lehrveranstaltung</p>	<p>The objective of the course Advanced Strategic Management is to provide students with an idea of the concept of strategy and its two major elements, i.e. strategy formulation and strategy implementation. It familiarizes students with contemporary theories, approaches, frameworks, and tools needed to develop and execute strategic decisions. It positions strategy and strategic management as the quest for value creation for relevant stakeholders that reaches beyond financial gains and short-term profits. Supplementing related courses such as 'Corporate Governance', 'Corporate Restructuring and M&A', or 'Business Analytics' ASM will primarily focus on the analysis of the competitive environment including technological megatrends, socio-political developments, and industries as well as on the analysis of internal resources, capabilities, and systems of the corporation. The concepts and elements of competitive advantage as well as of corporate strategies are outlined and applied. The course will additionally respond to a call in strategic management of including more micro-foundation by highlighting the role of individual and team decision-making. The use of accompanying cases, presentations of guest speakers, and in-class discussions will support the learning process.</p> <p>The main subject areas covered in the course are: the concept of strategy, the tools of strategy analysis, business strategy and the quest for competitive advantage, basics of corporate strategy, change management.</p>

Unterrichtsform	The course will use a combination of interactive lectures, guest lectures and group discussions. Class participation and active discussion is both expected and encouraged. Students are further expected to thoroughly read all the assigned course material / readings in advance of the class to ensure better understanding of the issues involved and to have meaningful class participation. Students should carefully read and be prepared to discuss topical issues. Students should expect to work outside of class time as foreseen in the normal calculation of credit points.

Art der Prüfung	<p>The assessment of the individual performance is based on two exclusive alternatives that must be irrevocably chosen until the fourth lecture:</p> <p>Alternative A (attending students): Class attendance must be at least 80% and there is no exemption with regard to possible guest lectures and the final lectures dedicated to the presentation of term assignments (planned for mid January 2027). Class participation and individual summary of three mandatory readings (20% of total grade): (ILOs 1. -5.) Individual term assignment (50% of total grade): (ILOs 1., 2.1, 3.1, 3.2, 4., 5.1) Written exam with options to choose from – 20 minutes (30% of total grade) (ILOs 1., 2.) NOTE: Term assignments are valid for the academic year 2026/2027 and cannot be carried over beyond that time-frame.</p> <p>Alternative B: Class attendance and assignments not required – final written exam of 80 Minutes (100%) –closed book– based on the script, textbook, and required readings (provided via OLE) with no choices. (ILOs 1., 2.) NOTE: Video recording of lectures is not provided.</p>
