<b>Specific Educational Objectives and Learning Outcomes</b>	<p>Some of the main critical junctures of the subject will be examined and the prevailing orientations in our legal system will be identified, starting from Italian and European legal texts and case law.</p> <p>At the end of the course, the student will acquire skills relating to the legal and deontological rules that regulate information and communication in the various spheres in which it is carried out.</p> <p>1. Ability to understand the questions relating to the subject matter;</p> <p>2. Thorough knowledge of the topics covered in the course;</p> <p>3. Ability to deal with the subject matter and answer questions not in a purely mnemonic manner, but on the basis of arguments and logical connections;</p> <p>4. Knowledge and understanding of the proposed concepts and</p>

	<p>study methods;</p> <p>5. Understanding of the legal-regulatory system governing the subject and ability to understand the value of the role of national and European standards.</p>
<b>Specific Educational Objectives and Learning Outcomes (additional info.)</b>	
<b>Assessment</b>	<p>The examination will be based on a written test consisting of open questions (2 or 3 open questions).</p> <p>In relation to the number of attending students (which will be verified in the first lessons), alternative routes for taking the final examination (e.g. intermediate in itinere examinations) may be identified.</p>
<b>Evaluation Criteria</b>	<p>The assessment indicators for the test are based on the ability to:</p> <ul style="list-style-type: none"> <li>- use knowledge (25%);</li> <li>- connect knowledge (25%);</li> <li>- to argue (20%);</li> <li>- deepen arguments (20%);</li> <li>- master the legal language (10%).</li> </ul> <p>In order to pass the examination, the student must achieve a sufficiency in all the open questions of the written examination, in accordance with the procedures that will be provided in class.</p>
