Ressumè di contegnus	This course provides an advanced introduction to financial reporting in multinational contexts, with particular emphasis on the preparation and interpretation of consolidated financial statements in accordance with International Financial Reporting Standards (IFRS). Topics covered include the accounting treatment of investments, the purchase method, full consolidation and the equity method applied to associates and joint ventures. The effects of foreign currency transactions on accounting are also discussed. foreign currency transactions, the translation of financial statements of foreign subsidiaries and selected advanced

	consolidation issues. Upon completion of the course, students will be able to critically analyse complex group structures and apply consolidation techniques in accordance with international standards.
