Excursion is part of the exam (mandatory). Exceptions will be admitted only upon a justified request.</p> <p>b. For students who are unable to attend classes regularly, an oral exam is available as the primary assessment method. The oral exam will cover the theoretical content of the course, the required bibliography.</p>
