<b>Ressumè di contegnus</b>	After a general introduction by the lecturer, the main topics listed below are worked on by the students in plenary sessions. In the course of the lecture, the students deepen and consolidate the knowledge they have gained by working individually or in groups on several assignments. Each thematic unit is followed by a discussion in which the respective phase of South Tyrolean contemporary history is not only considered in isolation, but also placed in a national and global context.
